



TERMS, CONDITIONS AND TECHNICAL SPECIFICATIONS

1. Rates to be quoted by the contractor should be filled in Bill of Quantities.
2. Rates to be quoted by the bidder shall be deemed to be inclusive of all types of direct and indirect taxes and local bodies such as excise duty, sales tax, GST.
3. Rates to be quoted shall also be inclusive of all royalties, fees and other payments in respect of patents, patents right and license(s) which may be payable to patentee, licensee or other person or corporation and shall obtain all necessary licenses/permissions.
4. All the works shall be completed within a period of 45 days from the date of issue of letter of acceptance by IKGPTU.
5. Payment Terms:
 - 95% payment shall be made on satisfactory completion of all the work in all respects. Balance 5% payment shall be made after three months of completion of work and removal of defects (if any) in the works. In this regard a satisfactory work certificate shall be issued by Director, Hoshiarpur Campus. Statutory deductions such as TDS, GST, Labour Cess etc. shall be made from the payments made by IKGPTU to the Contactor.
6. The contractor should have minimum 3(Three) years work experience of similar works and submit details of similar works executed in last 3 (Three) years along with documentary proof of work orders and satisfactory completion certificates.
7. The contractor should submit copies of PAN, GST, Aadhaar numbers along with the bid.
8. The bidder is advised to visit and examine the site where the work is to be executed and its surroundings or other areas as deemed fit by the bidder and obtain for itself on its own responsibility all information that may be necessary for preparing the bid and execution of the work. The cost of visiting the site and collecting relevant data shall be at the bidder's own expenses. It is a condition of the tender that the tenderer is deemed to have visited the site and satisfied himself with all the conditions prevailing including any difficulties for executing the work.
9. All the pages of this document shall be submitted by bidder duly signed and stamped by the bidder.
10. All the works shall be executed, measured as per Bill of Quantities/PWD CSR specifications and will be paid as per actual measurement at site.
